Purpose of the Grant and its Anticipated Benefits

Youth Business International were awarded £10,000 from The Company of Management Consultants' Charitable Fund in May 2018 to assist in funding our quality assurance work across our global membership. It was agreed that this money would be used to fund Accreditation assessment visits in 2018, to be conducted on a pro bono basis by nominated consultants from the Worshipful Company of Management Consultants (WCoMC).

The accreditation process has been designed to strengthen and sustain the quality and integrity of YBI members. Through using third-party assessors and an independent accreditation committee, YBI accreditation represents transparency and impartiality. Results Achieved from May 2018 to December 2018

Since receiving this valued grant from WCoMC Charitable Fund in May 2018, a total of six Accreditation assessment visits have taken place, with three assessment reports presented at the October 2018 YBI Accreditation Committee meeting, and three reports presented at the subsequent meeting on 6th December 2018.

Assessment of pre-accredited member, Adie (France), 31st August and 4th September 2018: Professor Robert Fonteijn conducted this visit in two parts. Firstly, he spent a day with Adie at their Head Office in Paris, which saw him meet with key staff members and one of Adie's major donors - Citi Bank. Secondly, Robert spent a further day with a Regional Director at a regional Adie office in Lyon. Being able to visit two locations as part of one assessment has been enlightening and provided some insight into how Adie can provide





<p>national coverage through the combined efforts of the Head Office and 13 regional offices.</p> <p>As well as being able to validate the strength of Adie’s operations (they are one of the transformative YBI members, having supported more than 20,000 clients in 2017), Robert’s visit has helped us re-engage Adie with YBI, and build stronger relationships between key staff members following a some role changes on each side. <p>Outcome: Following a presentation of the report by Robert Fonteijn to YBI’s Accreditation Committee, Adie have been awarded a <u>five-year, Unconditional Accreditation status</u>. This is the maximum accredited term that YBI is able to grant and is testament to the strength and potential of the member.</p>	

<p>Re-assessment of accredited member, Aliança Empreendedora (Brazil), 14th - 18th September 2018: Doctor Bob Harris carried out a re-assessment of our member in Brazil in September 2018, as their previously awarded unconditional status for three years was due to expire. Bob flew initially to Sao Paulo, where he met with the regional team and some young entrepreneurs who had been supported through the services provided by Aliança Empreendedora. He then proceeded to Curitiba (where the Head Office is located), where he was hosted by the organisation’s CEO.</p> <p>Bob was very impressed by how Aliança have tackled the physical challenge that they face in relation to the sheer size of the country, which is largely down to their adoption of digital to connect entrepreneurs with mentors and trainers who are geographically far away. Other key takeaways for Bob are linked to the strong presence of ethical values and accountability within Aliança.</p> <p>Aliança have taken on board some important recommendations from Bob in terms of enhancing the quality and impact of their mentoring programme, and the visit also provided a platform for the member to offer some thoughtful feedback to YBI in relation to their membership experience. <p>Outcome: Bob presented his report to the Accreditation Committee on 12th October 2018, and Aliança Empreendedora was subsequently award a <u>five-year Unconditionally Accredited status</u></p>	



<p>Assessment of pre-accredited member, Corporacion Minuto de Dios (Colombia), 17th - 20th September 2018:</p> <p>This assessment was conducted by Gia Campari; due to her knowledge of Latin America and her fluency in Spanish (CMD is one of the few YBI members that cannot communicate in English), she was very well placed to take on this challenge. Due to only running their entrepreneurship programme in Bogota, this visit occurred solely in the capital city. Through information provided by staff and volunteers, Gia is of the opinion that the resource raising strategy of CMD is the “<i>most comprehensive and effective</i>” that she has seen. She was also especially impressed with CMD’s specialism in socio-psychological support, which is indeed quite unique to the network. <p>Re-assessment of accredited member, Keren Shemesh (Israel), 15-17th October 2018: This assessment was conducted by long-time Worshipful Company member, but first time YBI Assessor, Malcolm Green. <p>Outcome: In line with the above, Malcolm’s recommendation to the Accreditation Committee on 6th December 2018 was that Keren Shemesh be <u>Unconditionally Accredited</u> for three years, and the Committee agreed with this recommendation.</p>	

<p>Assessment of pre-accredited member, Habitat (Turkey), 30th October - 1st November 2018: Experienced YBI Assessor, John Pulford, who has previously conducted assessments of YBI members in Bangladesh and Tanzania, visited the YBI member in Turkey at the end of October. In particular, his assessment focussed on reviewing Habitat’s flagship entrepreneurship programme ‘iMECE’ which is funded by UNHCR to provide entrepreneurship training for Syrian refugees in nine cities across Turkey.</p> <p>Whilst John’s assessment has revealed exemplary delivery of this programme (for which there is undeniably a huge need, with 4 million registered Syrian refugees in Turkey), he has not been able to recommended unconditionally accredited status for the following reasons: 1) there is a need for an independent Board with strategic authority to be introduced, and 2) in the absence of recently produced audited accounts, Habitat should commission an annual audit and ensure the resulting report is publically available.</p> <p>Habitat, which aspires to a goal of achieving international standards, recognises these points and has already taken steps towards the conditions detailed in John’s report.</p>	<div data-bbox="1098 734 1426 810" data-label="Image"> </div> <p>Member name Habitat Country Turkey Date joined YBI 2016 Website habitatkalkinma.org Assessor John Pulford</p>
<p>Outcome: The Committee agreed with John’s recommendation was for <u>Conditionally Accredited status for 12 months</u>, subject to Habitat addressing the points names above.</p>	

<p>Re-assessment of accredited member, MicroLab (Italy), 12-14th November 2018: Like the Habitat assessment, the assessment of MicroLab was also conducted by an experienced YBI Assessor, John Corneille. John started his visit MicroLab’s HQ in Turin, and subsequently travelled to the newly opened regional MicroLab office in Naples. With thanks to the valuable support from WCoMC, the YBI Network now comprises 37 members (out of total of 53) that have achieved Unconditionally Accredited membership.

Allocation of funds

For all the assessment visits stated above, the grant from WCoMC Charitable Fund contributed £5,000 toward the cost of flights, accommodation, taxi travel, vaccinations and meals for Assessors. The remaining £5,000 has been allocated to YBI staff costs, to cover the time required from the Director of Network Members, the Network Members Manager and the Network Members Officer in supporting Assessors, leading logistical arrangements, and liaising with YBI members in order to facilitate these visits.

Next steps

We have already commenced planning for three more assessment visit which will take place at the start of 2019. These include:

- Assessment of pre-accredited member, ideaLab (Mozambique) - to be conducted by WCoMC Assessor, Jeff Herman in February 2019.
- Assessment of pre-accredited member, Fate Foundation (Nigeria) - to be conducted by first-time Assessor, Chris Sutton, in March 2019.
- Re-Assessment of accredited member, Futurpreneur (Canada) - to be conducted by Bob Harris, timings TBC.
- Re-Assessment of accredited member, Virgin Startup (UK) - assessor and timings TBC.
